# 2008 ADF Spring Business Meeting Miami Florida Monday May 5, 2008

Before the meeting was called to order ADF Secretary Patrick Boyle announced the intentions of recording the meeting on audiotape for preservation and documentation. All parties were advised that the if there subject was that of a sensitive matter the audio recording would stop for that portion of the meeting. No objections were noted.

### Adam Giraldes ADF President / United Airlines

- To begin the meeting ADF President Adam Giraldes thanked all of the delegates for attending the business meeting and all of their hard work since the Winter meeting.
- In addition Adam wanted to thank the labor groups for attending our meeting and for their continued support.
- At this point Adam began the introductions of all that were attending the meeting.

#### **Old Business**

- 1. Old ADF to New ADF
  - The change over from the old version to the new version of the ADF has not taken place. All documentations are at the lawyer for review and that the change over should be completed by the summer business meeting.
- 2. Contract dispatching
  - As of this point we have been assured by the FAA they are not pursuing the contact issue and that for now it is a dead issue.
  - The ADF has a letter on file from the FAA Associate Administrator Nicholas Sabatini stating that this is something that the FAA does not want to pursue.
  - The ADF received assistance from the office of Congressman Jim Oberstar (D-Minn)
  - The ADF is waiting for a possible meeting with the FAA. At this time the ADF has not been granted a meeting time.
  - Three members of the ADF board did meet with Jeppessen at there offices. The meeting was productive but in the end it was thought that they were looking for more of an endorsement from the ADF.
  - Continued monitoring of this topic will be needed especially with an administration change in November of this year.

#### Officer reports

Joe Miceli ADF Vice President / United Airlines

- ADF video project
  - The project has been slowed since the last meeting due to his work schedule at United.
  - The script is completed and is at a third party for review of continuity and grammatical problems.

- Should have a trailer ready by the summer meeting in ORD
- Will have a report back at summer meeting
- Went to YOW to complete filming for a segment in the video about the dispatcher of the past.
- Has been attending the JPDO NextGen ATC meeting to keep a dispatcher preference.
  - Not currently on a committee, but shows to keep a profile that dispatcher are in currently
  - Adam also jumped in about the NASA/AMES project about dispatch and the communication we need in NextGen.
- Joe advised the group that he would not be able to attend the July meeting due to schedule conflict.

# Patrick Boyle ADF Secretary / Expressjet Airlines

- Attended the Data link users forum San Diego.
  - The DLK user forum is mainly a group of designers and satellite providers working with the FAA to produce standards on the use of and protocol for use of data link (CPDLC).
  - Brought to their attention that voice needs to always be there as a back up.
  - Also noted to the group, that dispatcher need to be kept in the loop and a part of the decision making process between ATC and the pilot.

## Sandy Sandziuk IFALDA / Air Canada

- ICAO conference in Delhi India
  - Titled "Contemporary issues in air transportation"
  - IFLADA taking a great deal of interest in this conference due to several issues it is bringing up. Some of these issues are
    - How have ICAO safety audits affected commercial aviation
    - The state of these audits and compliance to them.
    - Is it time to reinvent the "Chicago Convention"
    - Is it time to revamp ICAO
  - In July EASA becomes effective and they then have the legal standing to start rulemaking for Europe.

  - Working with ICAO over concerns on how amendment 30 of ANEX 6 is being handled.

- Dispatcher fatigue
  - The ADF has been invited to attend a fatigue symposium by the FAA
  - Adam will be attending this symposium
  - They are looking into can a dispatcher call fatigued and what would or could be implications to this?
- Adam will be meeting with a NASA sub contactor with regards to NEXTGEN and how it will affect the dispatcher.
