2011 Summer Business Meeting

July 16, 2011

1. Call to order

- ADF Secretary Patrick Boyle called the business meeting to order at 1305 local.
- ADF President Joe Miceli thanked all who were in attendance.

2. Roll Call

- As there were several new members at the meeting the group conducted roll call.
- 3. Meeting Minutes from Previous Board Meeting (DFW 03/23/2011)
 - The meeting minutes were passed around the room for those were unable to read the minutes before the meeting.

4. Officer Reports

- a. Presidents Opening Remarks / Nominations (per bylaws)
 - ADF President Joseph Miceli once again thanked all who could be in attendance for this important meeting.
 - Joe advised the group that currently there are only two official logos patented by the ADF. Since these are registered to the ADF all communications must use only these logos.
 - Joe advised the group that nominations are still open for the positions of President and Executive Treasure.
 - i. Joe Miceli has been nominated for President.
 - ii. Mike Timpe has been nominated for Executive Treasure.
 - iii. Nominations will remain open until the opening of the Fall Business Meeting in LAS.
 - iv. Nominations may be e-mailed to Joe or ADF via email.

b. Presidents Report

- Joe attended the NACSC meeting on June 9th in Washington DC.
 - o Joe passed around a recap sheet and presentations from the meeting.
 - The reoccurring theme at the meeting was the FAA budget and how it may be reduced to 2008 budgetary levels.
 - There is also word that the spending levels may be decreased to 2006 budget levels.
 - Many groups around the FAA are discussing if monetary projects will have funding spread out evenly or if projects will be picked over other projects.
- Friends and Partners in Aviation Weather (FPAW)
 - o Joe attended the FPAW planning meeting on July 14th in DCA.
 - o Joe gave a brief overview of what transpired at the meeting.
 - Once again the big issue was the FAA budget.
 - o From the meeting Joe also found out that:
 - President Obama is committed to NextGen and may cut other programs

- Within NextGen many cost overruns are showing up. The FAA is restructuring to clean up any overruns.
- 70% of flight delays within the NAS are weather relegated.

- RTCA

- Joe advised the group that the RTCA has sent a letter to Administrator Babbitt of what has transpired within the RTCA.
- o Joe attend the Spring RTCA symposium in Washington DC.
 - As in other meetings the big buzz was the FAA budget
 - There is a push to put priorities on what is needed and what is to be considered extra
 - ATC Controllers will manage but not control
 - UAV's are a new subject that is being discussed
 - Right now the plan for NextGen is baby steps before beginning to run.
 - In many areas there is a lack of a business case for many of the NextGen projects.

- Video Project

 The new ADF video project is now back on hold until the response to the SNRPM has been completed. The executive board felt that it is better to put all time and resources towards the SNRPM at this time.

- SNRMP Response

- o The board is working on the SNRPM response.
- o For now the response deadline has been extended to September 19, 2011
- Several of the talking points the board is discussing are
 - Duty time issues
 - AQP
 - Ops Specs restrictions
 - Safety
 - Risk Assessment
 - The SNRPM works against SMS
 - Value of a company employee
 - Extended Tarmac Procedures
 - Contingency Plans
 - Synergies
 - Lack of a study for contract dispatching
 - Conceptual design
 - Accountability
 - Liability for loss of aircraft
 - Governing
 - Human Factors
- With the extension we have more time to prepare ADF's case concerning Contract Dispatching.
- ADF tactically will submit its response three to four days before the deadline.

- Joe has been invited to attend a meeting of Brazilian Dispatchers and Government discussing and presenting US FAR-121 Dispatching and Operational Control. SA Officials, Pilots, dispatchers, and operational specialists will discuss dispatching practices within their current structure.

- The next NACSC meeting will be on August 2nd
- The FPAW meeting will be held in conjunction with the NBAA meeting in October in LAS.
- EUFALDA AGM will be in Prague on October 21-23, 2011
