# a. Opening Remarks/Nominations of ADF Board Members (EVP/Secretary per bylaws)

### b. Presidents report (NACSC, FAA, Airports Project, Video Update)

- Mr. Miceli attended the RTCA Symposium on June 5-6.
  - Joe passed along to the group presentations and notes from the meeting.
  - The FAA NEXTGEN budget has been approved by congress.
  - o TWU Local 542 John Plowman was in attendance with Mr. Miceli.
  - The symposium was informative.
  - o There is a large push to move forward with NEXTGEN.
    - At this time there are many directions from all sources so there is no clear direction yet.
    - Dispatch needs to be part of the CPDLC when it comes to clearances, reroutes, and delays.
    - At this time there is no back-up set up incase of failure.
  - The big shock was the announcement of Chris Aswalt stepping down as chairman.
  - o ADF is attending and advocating the dispatch profession.
- Mr. Miceli attended the FAA Airport Project looking into the use and format of airport NOTAMS.
  - The group is looking at simplifying NOTAMS.

- The group is also looking at shortening then amount of NOTAMS issued.
