Airline Dispatchers Federation 2012 Winter Business Meeting January 28, 2011 Tampa Florida

1. Call to Order

 ADF Executive Secretary Patrick Boyle called the meeting to order at 1300 EST.

- Joe attended the NBAA/FPAW meeting in October.
 - The conference went well as ADF was part of the FPAW panel. The group in attendance recognized the importance of PIC, Aircraft Dispatcher, and ATC controller triangle of safety. ADF will be invited to FPAW's 2012 pre-meeting (May) and NBAA 2012 events (OCT-NOV) in Orlando.
- Joe Attended the EUFALDA AGM in Prague.
 - Mike Timpe was also in attendance. (Joe left immediately after EUFALDA conference due to a death in the family)
 - EUFALDA is working hard on getting dispatchers into the European Aviation Community.

- Joe Attended the FAA Flight Diversion Planning workshop in Washington, D.C.
 - The FAA recognized they are also having difficulties at airports when mass diversions occur due to weather/field conditions.

 - o As part of the meeting Joe also attend the Airline Ops workshop.
 - The FAA plans to build a website to help with mass diversions.

 - To date, no fallback procedures have been designed into NextGen. (any solar flare up are would be a huge problem for NextGen)

 - o Norm Joseph advised there is an RFP/Comments for data comm.
 - All groups, ALPA, ADF, and NATCA are concerned with Datalink and AdsB-out/in
 - The group discussed what would dispatchers need to work their flights
 - There is a study going on for a retool that links pilot, controller, and dispatch.

- Joe advised the group that the video project should be completed by the fall symposium.
 - o The video will be copy written.
 - o The group discussed the pros and cons of copy writing the video.
 - Catherine Jackson brought up that the video could be used to sign up new members for a fee.
