- j. Other Business/Legal
 - Recently a group of ADF members had asked if ADF was still chartered by IFALDA and are ADF members required to be IFALDA members. Not knowing the answers to these and other questions, ADF deferred to ADF Legal for further clarification.
 - 1. After thorough research by ADF Legal, the following has been clarified:
 - a. The change from "Old ADF" and the "New ADF" has caused significant changes in ADF's structure including collection of dues and tax liabilities.
 - b. Of these changes, the "New ADF" is not chartered by IFALDA and now it's own incorporation.
 - c. As ADF is legally is it's own incorporation with changed 501C tax ID, ADF cannot collect IFALDA membership dues as in the past. (With "New ADF", all agreements with "Old ADF" are null and void)
 - d. Beginning in January 1, 2011, ADF will not collect dues for IFALDA however ADF will continue to be strong supporters of IFALDA and it's efforts. (board members will be fully vested)
 - e. January 1, 2011, ADF dues will revert to \$30.00 per member (as in previous years) and IFALDA will be responsible collecting their own membership dues from supporters.
 - f. ADF will structure it's website to allow either a drop down box forwarding IFALDA dues (single members) and/or add a link which goes directly IFALDA's website for dues collection.
 - g. ADF will revert to a Jan 1-31/Dec 31 dues collection cycle for it's union supporters.
 - 2. Sandy Sandziuk of IFALDA issued a report from IFLADA regarding the change
 - a. A quick resolution is needed with these changes
 - b. Still looking into it's implications
 - c. Gave a brief overview of how IFALDA and ADF came to be.
 - d. IFALDA has a limited way of collecting funds with its 2 websites.
 - e. Would forward on this information.
 - 3. ADF President thanked Sandy for his comments and noted that IFALDA's business dealings should not be tied to ADF's collection of IFALDA's dues. It should be business as usual for IFALDA with ADF's full support from its board today, and in the future.

- 4. Paul Viola asked if the ADF could set up an escrow account to continue to pay IFALDA dues
 - a. Due to legal costs, financial liabilities, and tax codes, ADF will not be able to handle any IFALDA monies after December 31, 2010. Helping with this new dues transition, ADF's Executive Board agreed to pay all IFALDA membership dues in full until April 30, 2011. (with the exception of a few single members who joined online)
